The Red Hill Driving School is pleased that your son/daughter has been admitted to this session of driver education at Moultonborough Academy. The format for the winter/spring program will be on **Saturday and Sunday**. The first class will start on Saturday, February 15, 2014 at **8:00-10:00 am**. Your instructor will be Karel Crawford.

The Program will consist of **30 hours** of classroom instruction, **10 hours** of “on the road” driving instruction and **6 hours** of road observation. The student will also need **40 hours** of additional practice time documented with a parent or legal guardian 10 of those hours must be at night in order to receive a New Hampshire license. **Parents must drive with their son/daughter after a driving lesson with instructor to reinforce the instruction that the student is receiving from the teacher. If this is not being done the student will find it difficult to progress in this program.** It is a state regulation that your child may not miss any classes unless it is for just cause i.e.: death in family, emergency illness (maximum 4 hours). **A note from the parents must be sent with the student for state records.** If this should occur they must leave this class and begin where they left off in the next driver education class that is offered. The student has 6 months (by state regulation) to complete the course, if not completed in 6 months they must take the complete course again with tuition costs. Students must be on time for class, tardiness will be counted as time missed and make-up work will be assigned at the instructor’s discretion. They are expected to take class notes, pass in all assigned work and attain an 80% average for the work assigned. Failure to pass the course means the student will take the course again at the parent’s expense.

All students are expected to exhibit cooperation, consideration and respect for their fellow classmates and instructors. We have a no tolerance policy; we will not accept rude or disruptive behavior or any violation of the school or State drug and alcohol rules and regulations. Any student who violates any of the aforementioned rules or displays and exhibits this type of behavior will be immediately dismissed without refund, and not allowed back into any future classes proved by Red Hill Driving School. If a student is suspended or absent from school he will not be allowed to attend driver education classes on that day. We take driver education very seriously and we expect the students to also. DRIVING IS A PRIVILEGE NOT A RIGHT.

Tuition is non-refundable commensurate with the attendance of the first class. If class or driving time is to be canceled by the instructor, notification to the student or the school will be done by phone. Because of the expense involved and rescheduling problems, it is imperative that the student be present for the road instruction appointments. If the student gives the instructor 24-hour notice that he is unable to make his appointment, no fine will be imposed.

If proper notice is not given for a broken appointment a \$35.00 fine will be charged and must be paid before the student is scheduled to drive again. If the student misses a two (2) hour driving appointment the fine will be \$65.00. This also includes observation appointments. The absent student's driving time will be rescheduled at the discretion of the instructor. **NO CLASSES DURING SCHOOL VACATIONS**
